

**DE PAUL UNIVERSITY**  
**2021 BLUE DEMON VACCINE CONTEST**

**OFFICIAL RULES**

1. **Eligibility.** DePaul University's Blue Demon Vaccine Contest is open to students enrolled in one or more courses at DePaul University for Fall Quarter 2021-22 who submit acceptable evidence to the university that they have been fully vaccinated for COVID-19 on or before Aug. 19, 2021, at 11:59 p.m. CT. 2. **Sponsor.** The Blue Demon Vaccine Contest is sponsored by DePaul University, an Illinois not for profit corporation with its principal place of business located at 1 E. Jackson Blvd., Chicago, IL 60604.
3. **Compliance with Official Rules.** Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all of the requirements set forth herein.
4. **How to Enter.** All students who submit proof of COVID-19 Vaccination to [Campus Connect](#) prior to Aug. 19, 2021, at 11:59 p.m. CT, will be automatically entered into the Blue Demon Vaccine Contest. All late entries will be considered void. No purchase is necessary to enter the Blue Demon Vaccine Contest. A purchase will not increase an entrant's odds of winning the Blue Demon Vaccine Contest.
5. **Prize Drawing.** On or about Aug. 20, 2021, DePaul will select potential winners in random drawings from among all eligible entries received. Once a potential winner is selected, they will not be eligible for subsequent prize drawings. The odds of being selected depend on the number of entries received.
6. **Winner Notification.** The potential winners will be notified via their DePaul email address. If a potential winner cannot be contacted, fails to respond to DePaul within 10 days, or if a prize is returned as undeliverable, the potential winner forfeits their prize. If a potential winner is a minor in their state of residence, DePaul reserves the right to award the prize in the name of the winner's parent or legal guardian. Winning is contingent upon fulfilling all requirements. In the event that a potential winner is disqualified for any reason, DePaul will award the applicable prize to an alternate winner by random drawing from among all remaining eligible entries. Prizes will be fulfilled within approximately 30 days after the conclusion of the Blue Demon Vaccine Contest.
7. **Prizes.** Random drawings will be held for each of the following prizes, in the following order:
  - Apple AirPods Pro \$250
  - \$500 gift card to Barnes & Noble bookstore

- Suite for the winner and up to five friends to attend a men's or women's basketball game at Wintrust Arena \$1,000
- \$2,500 grant towards their cost of attendance

Prizes may be subject to tax reporting and applicable withholding.

8. **General Conditions.** In the event that the operation, security or administration of the Blue Demon Vaccine Contest is impaired in any way for any reason, including, but not limited to, fraud, virus, bug, worm, unauthorized human intervention or other technical problem, or in the event the Contest is unable to run as planned for any other reason, as determined by DePaul in its sole discretion, DePaul may, in its sole discretion, (a) suspend the Blue Demon Vaccine Contest to address the issue and then resume the Blue Demon Vaccine Contest in a manner that best conforms to the spirit of these Official Rules; or (b) terminate the Blue Demon Vaccine Contest and, in the event of termination award the prizes at random from among the eligible, non-suspect entries received up to the time of the impairment. DePaul reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operating of the Blue Demon Vaccine Contest or to be otherwise acting in violation of these Official Rules or any university policy.
9. **Release and Limitation of Liability.** By participating in the Blue Demon Vaccine Contest, entrants agree to release and hold harmless DePaul, its trustees, officers, employees, representatives, and agents (the "Released Parties") from and against any claim or cause of action arising out of or relating to participation in the Blue Demon Vaccine Contest or receipt or use of any prize awarded. The Released Parties are not responsible for any false, incorrect or inaccurate information submitted to DePaul for entry into the Blue Demon Vaccine Contest. Entrants waive the right to claim any damages whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages relating to their participation in the Contest.
10. **Privacy.** Vaccine information collected from entrants is subject to DePaul's privacy policies and will be protected in accordance with applicable law, including but not limited to the Family Educational Rights and Privacy Act (FERPA, 20 USC 1232g).
11. **Governing Law.** The Blue Demon Vaccine Contest shall be governed in all respects by the laws of the State of Illinois.
