

Vanessa Esparza-López

Vanessa Esparza-López is a supervising attorney with the National Immigrant Justice Center where she represents individuals before the U.S. Department of Homeland Security, U.S. Department of State, and U.S. Department of Justice. Vanessa is an active member of the American Immigration Lawyers Association (AILA), where she currently serves on the Chicago AILA District Director Liaison committee. Vanessa is also a Board Member of P.A.S.O. (*Proyecto de Acción de los Suburbios del Oeste*/West Suburban Action Project), a community-based social justice organization with the mission to build stronger communities where all residents can live dignified lives regardless of their race, socioeconomic or immigration status. She obtained her J.D. from DePaul University College of Law in 2009 and her Bachelor of Arts with honors in International Studies from DePaul University in 2006. During law school, Vanessa was the cofounder of a new student group, the Society for Asylum & Immigration Law.
